# PRESIDENT.

Don't Be Fooled, Follow the Facts, Do Your Own Due Dilligence and Make Informed Decisions

I feel compelled to open my remarks with this appeal since false information is being spread by a few in attempt to block sensible and necessary revisions to our governing documents especially with respect to statutory reserves. In no way do statutory reserves give the board the right to raise the reserves without control. The law provides for the right to waive or partially fund reserves by a vote of a majority of those present at a meeting where a quorum is met (30% of the total voting interest). Any claim to the contrary is simply false. You should have already received a package containing separate amendment documents and important background information to aid you in making a voting decision that is right for you and our community.

The board has established a hotline number, 813.534.0106, to provide answers to any questions you may have regarding the proposed amendments. We kindly ask you to be respectful of your board, who are volunteers, when calling.

You may be aware that our property manager, Kristen Deroche, tendered her resignation and left Lake Forest HOA on January 24, 2025. Her replacement, Dominique Green, who is a licensed Community Association Manager (LCAM), started on February 24, 2025, and will go through a few days of training before starting to work from the office. She joins us from Cory Lakes.

The roof repair campaign is in its third phase. Delays in getting feedback from owners made it impossible to complete the repairs earlier. I want to thank all those who gave us their consent to perform the necessary repairs and those who choose to use their own licensed contractor. Some homeowners have not yet responded to the three notices we've sent and may force us to exercise our right to abatement.

All fallen trees and root systems as well as all debris from hurricane Milton have been collected by the County and our contractors.

Large areas of crumbling concrete at the end of Morning Drive were replaced during the week of January 6. Thanks to all adjacent owners and residents for their cooperation and the contracts for installation of Hardie siding at buildings 14, 50, 59 and 60 were signed on Feb. 5, 2025. Work should begin within the next ten days at building 14.

Destroyed mailboxes at building 55 were rebuilt and paid for by the driver's insurance company.

All open and pending work orders are under review and will be addressed as soon as reasonably possible.

A revised streamlined collection policy which adds a few more grace days to pay and eliminates reminder letters, is in full compliance with the law (Chapter 720) and will be mailed to you shortly.

We have a Yard Sale scheduled for March 8th and our Spring Cleaning event, which includes shredding and Salvation Army donation trucks along with a dumpster is scheduled for Match 29<sup>th</sup>. Stay tuned.

Things to keep in mind...

- Assessments are due on the first of each month
- Assessments not paid within 30 days incur a 6% interest penalty
- The Thirty Days' Notice of Late Assessment (NOLA) letter is sent on the 34<sup>th</sup> day after the due date. Delinquent homeowner is charged \$25 for the NOLA. There will be no reminder letter.
- Homeowner will be charged for each collection attempt
- Homeowner will be billed for any additional Attorney charges
- Once an account is transferred to the Attorney for collection, all communications regarding the delinquent account must be directed to the Attorney until the account is paid in full
- Attorney charges are currently billed at a rate of \$250 per hour

NOTE: It is the member's responsibility to ensure assessments are received on-time, paid-in-full, and properly posted to the member's account to avoid penalty & potential collection actions.

Thank you for all of the kind words recently! I have really been enjoying meeting and chatting with so many of you on my daily walks with my dogs. I think it's also safe to say that the dogs enjoy it as much as I do.

#### Market Report:

You may have noticed the increase in recent sales in Lake Forest! We had 4 single family homes and 1 townhome sold in the last 3 months. The single family homes sold, on

average, for \$224 a square foot. The townhome (a 2 bed, 1.5 bath) sold for \$225,000. The average days on market before going under contract is holding steady at 53 days. If you're curious about the market value of your home, reach out to me for a custom analysis.

Spring is just around the corner! Now is a great time to have your annual plumbing inspection. A certified plumber will check for any leaks in lines or in your toilets. #### Landscape Committee - New members and projects

Hi all, I wanted to let everyone know that the Landscape Committee has undergone a series of changes... Betty Alamo is the new Chair, and along with Cathy Thomas and Patrick Nagy (our newest member) we are looking forward to serving our community's landscape needs. We are currently focused on upgrading our plantings along Lake Forest Drive, by fertilizing, adding some healthy garden soil and laying down mulch where needed. We are also looking at establishing a butterfly garden so the youngest members of our community can learn about and experience the life cycles of our Florida butterflies.

Once this project is completed we will focus on upgrading the gardens surrounding our pool, hopefully in time for the summer pool season.

Of course, these projects will require upgrades and repairs to our irrigation system so we will be keeping a close eye on expenses and trying to stretch our landscape dollars to accommodate

Next will be addressing the rusted wrought iron fences located by our lakeside townhomes. We will be obtaining estimates for removing, repairing and/or replacing fences as indicated – again, another costly project.

As a priority, we will also be meeting with arborists in order to identify old, dead, and diseased trees – those trees that have reached the end of their natural life expectancy and are a hazard to our community and property.

In the meantime, Patrick is working with Gert to apply for a tree grant from Hillsborough County to cover some of plant expenses. Thank you Patrick!

#### FRIDAY is main trash day (Recycling, Regular pickup & yard trimmings)

Leave bagged yard trimmings at curb near garbage bins. Boxes need to be broken down to fit inside the recycle bin. Do NOT leave any furniture, mattresses, or over-sized boxes out. The city will not take anything that doesn't fit in your garbage container. **Tuesday is only regular trash bin**. Don't forget to put away your trash bins!

#### **Importance of Updating your Contact Information**

So often property owners tell us that they are not receiving important information (such as late payment notices) and it is important to make sure all official HOA correspondence reaches you in a timely fashion.

Please take a moment to verify your mailing address on the County's Property Appraiser's website and change / update it as needed. The form can be found via https://www.hcpafl.org/Portals/HCPAFL/pdfs/ChangeOfAddressRE071615.pdf.

Ensuring your information is accurately reflected on the Property Appraiser's website also permits homeowners to claim Homestead Exemption (if the property is owner occupied) leading to lower property taxes. Everybody loves to save on their property taxes!

We also recommend ensuring that your contact information is updated in the Lake Forest Homeowner's Association website - https://condo.cincwebaxis.com/. You don't want to miss out on any important communications (such as Social Committee events) from our property manager!

#### No Trespassing

There are new No Trespassing signs at the end of Morning Drive and the end of Lake Forest Drive. Please note, Lake forest residents are not affected. The signs are for non-residents who go to North Lake for fishing. Our streets are public so we can't prevent anyone from entering Lake Forest nor driving on the streets within our community.

Please always carry a bag with you to pick up after your dog. All feces must be picked up immediately. It is not allowed to be left on any common ground, sidewalk, or recreation area.

And NEVER put the waste bag in someone else's garbage bin. We've had some complaints about this happening on trash days. All dogs must be on a leash per Hillsborough County Ordinance.



Please be aware of your surroundings and use caution when approaching any of the lakes' edges since alligators

may be present. Stay at least 30 feet away, especially when walking with small dogs or children. Pay attention to the posted warning signs. **Do not feed the wildlife!**
