Budget/Yearly Assessment

At the Budget Meeting in November, the HOA Board approved the budget for 2025. The Annual Assessment will be increased by 10%, bringing the new fee to \$87.80. One reason this is necessary is that the board has purchased General, Property, and Liability Insurance in the amount of \$79,000, helping to create a \$124,000 deficit in the budget. Whatever you're thinking about insurance right now, the board had the same thoughts. It is highly recommended that HOA Boards carry this insurance to protect them in case they are being sued, among other reasons. Because we have a healthy savings account, we can cover the deficit this year, but we would run out of money sooner rather than later should we continue to operate at a deficit year after year.

If you have not yet received your 2025 Assessment notice, it should arrive in your mailboxes soon, either through email or snail mail depending on how you have chosen to receive these notices. Payment is due on Jan.1, 2025. If you do not receive it by mid -month, please email RealManage, our management company, at LexOaks@ciramail.com for assistance.

Things to remember:

- ⇒ All hurricane shutters/boards should have been removed a while ago.
- ⇒ All Halloween decorations should have been removed by mid-November.
- ⇒ Tree debris piled at the curb will not be picked up during trash collection unless it is bundled and in 4' lengths. It will also be picked up if it is cut to fit in your garbage cans.
- \Rightarrow Please do not park in front of or across from anyone's driveway.

HOA Board Positions

Voting for the new board will take place at that meeting.

Here are some housekeeping items:


- Pick up after your dog! This still remains a problem.

Become A "Safe Shopper" With Tips From PSO

As the holiday season quickly approaches and shopping picks up, the Pasco Sheriff's Office is



preparing shoppers for the crimes, scams and gimmicks that often occur this time of year. In the rush of the busy season, it's essential to remain vigilant and learn how to stay safe, whether you're planning to complete your holiday shopping in person or online. Before you shop-til-you - drop, PSO encourages reading the safety tips below.

While you dash from store to store, it's easy to become distracted and overlook potential criminals who might be doing some "shopping" of their own. Stay vigilant when you arrive at your destination, including time spent walking and driving through the parking lot. Park in a well-lit and visible area. When exiting your car, take your belongings and hide any large packages out of sight. Ensure your car windows are closed and the doors are locked before heading inside. Once inside the store, remain aware of your surroundings, and be cautious with your purse and wallet. It's safer to shop with someone you trust, as thieves are less likely to target people in groups. If you're shopping with children, designate a specific meeting spot in case you get separated. Consider taking large purchases home immediately before continuing your shopping.

Online stores may seem safer than traditional brick-and-mortar stores, but there are just as many dangers online as in person. Start shopping safely online by using a secure Wi-Fi network instead of public Wi-Fi. PSO also recommends checking that the site is legitimate by looking for http:// at the start of the URL. Be cautious of phishing attacks through emails, phone calls and texts, and avoid clicking on links or pop-ups. When possible, use credit cards instead of debit cards - they generally offer better fraud protection.

After shopping online, the next step is being aware of "porch pirates." Package theft is a crime of opportunity and often increases during the busy holiday season. Request a specific delivery day/ time when you'll be home. Have packages delivered to a community office or a trusted neighbor that's home if you know you won't be present for the delivery. If you still would like the package delivered directly to your home while you are away,

Hello Neighbors,

This is going to be our 20th Christmas in Lexington Oaks. That's the longest we've ever been in one place and I'm glad it's here in Lexington Oaks with all of you. We still have several neighbors on our street from the very beginning in 2004. Of course, many of them have moved on for varying reasons. One neighbor actually moved because the horses were added at the front entrance. They were exceptionally good neighbors too. For those of us who remain, we've planned an upcoming block party celebration for our street and another one for New Year's night. Covid disrupted us for the last few years, but we are so back. There's nothing like hanging out with neighbors, old and new, and forging long-lasting relationships. That's the street I always envisioned I would live on.

I hope everyone made it through the hurricanes without too much damage. If you didn't, I sincerely hope you get back to normal as soon as possible. Speaking of damage, the CDD took quite a hit. At last count, we're removing around 162 trees at a cost north of \$100K. That includes the cut, disposal and grinding of stumps. According to our accounting group, we were able to carry over from FY24 about 100K that will be used to help supplement these expenses. We are in the beginning stages of replacement options for areas needing replantings. Additionally, we still have a lot of work with broken or damaged limbs to perform, so we appreciate your patience as we work to restore the common areas back to normal.

Last year, the CDD put out tons of messaging about overdue tree work on the boulevard and budgeted for a massive tree pruning project. That extensive tree pruning was performed in early FY24 and turned out to be rather timely. Why? The thicker the tree canopy, the more resistance the tree receives, and it effectively becomes a parachute that contributes to uprooting the tree. The root structures of oaks are not deep enough, especially in Florida soil, to withstand high force winds, causing them to often topple. Because of the pruning project, damage to our oak trees was very minimal. Obviously, it seems like a good idea to occasionally prune your own trees to mitigate tree damage. Just a thought.

Quick bullet points:

- There two new machines in the Fitness Center, an elliptical and multi-functional weight machine.
- We are replacing one of the pool awnings and several tables that was damaged by the Hurricane.
- Pond 27D in Pimlico will be restored to its original permitted depth in January.
- The Christmas lights have been installed at the front entrance.
- Congratulations to Butch Straber for winning CDD Seat 5. We look forward to working with you.
- Watch out for our children while they are out of school for the holiday season.

Final thought: The CDD Board would like to thank Supervisor Pete Williams for stepping up and serving out the CDD term for Seat 5. Pete is undoubtedly the most experienced CDD individual that has ever sat on this Board. Pete has been in the CDD service industry for many decades and serves as a consultant to CDDs in multiple states His advice is sought after and invaluable. What really stood out to us is that, despite dealing with difficult personal circumstances, Pete still found time to attend our meetings and provide excellent guidance. Pete has graciously offered to be a continued resource to the Board and Lexington Oaks is very fortunate to have him as part of our community. Thank you Pete. We wish you well.

leave specific instructions for delivery that include a location out of sight from the road. An additional option is to have shippers hold the package at a pick-up facility.

By posing as charitable organizations, scammers exploit those trying to make a difference. PSO encourages researching and reading reviews for charities you are interested in supporting. If the charity contacts you directly, verify the contact information on their website. If you donate, don't pay in cash, by gift card or wiring money. Ensure you're not signed up for recurring donations.

As you look for great deals, remember this information to be the ultimate safe shopper. And don't forget to share these tips with your loved ones to prevent them from becoming victims


