#### **ASSOCIATION'S 2024 YEAR IN REVIEW**

The Association had another great year! Our largest investment (\$11,320) was the further renovation of the Van Dyke Road Entrance landscaping. Several aging ligustrum were removed and replaced with robellini palms. Several pallets of St. Augustine sod was also replaced. Other projects included the replacement of the fence (\$5,655), the addition of four community benches (\$3,844), the re-flooring and painting of the Clubhouse meeting room (\$3,438), and the Hurricane Milton cleanup, which the Association spent \$6,200 removing downed trees and stump grinding. Much of the actual debris was removed by member volunteers, substantially minimizing costs.

As is the case each year, several significant recurring projects were completed including the annual landscape mulching (\$6,278), sidewalk and monument pressure washings (\$7,397), and playground mulching (\$1,241). The annual mulching was completed in March as thirty member volunteers laid 1,600 three-cubic feet bags of mulch. The mulching of the playground was also done by member volunteers. The community pressure washing was completed by Tampa Power Washing.

Administratively, the Association continued to make improvements and effectively manage our contractors. One great addition is the Association's fully updated Vantaca web portal administered by Greenacre Properties. The portal contains a wealth of information for members and allows owners to pay their annual assessments online. Owners can also submit Architectural Control Committee (ACC) applications online and track them in real time. The portal also keeps members up to date on Association matters as Board Meeting materials, with all attachments, are posted on the portal well ahead of meetings. If anyone is not actively using the portal, please strive to do so. We'd like to get all owners using the portal to continue to reduce printing costs and ensure everyone is receiving critical Association e-notifications. Please contact our Community Association Manager, Laura Coleman, at Icoleman@greenacre.com for assistance in using the portal.

Long-term contracts continued to be appropriately negotiated and managed. Year over year price increases were held to zero to three percent, with the exception of insurance coverage that increased by eight (8) percent from 2023 to




2024. Of note, the Association continues to minimize legal costs, spending just 61 percent of the legal budget (\$12,241 of \$20,000). Much of this savings is due to the Association now sending out Fine Notices (less than \$5) versus a



## ASSOCIATION'S 2024 YEAR IN REVIEW CONTINUED FROM PAGE 1.....

Legal Notices (at least \$195) when an owner fails to remedy a violation within the allotted timeframes (often 30-days per notice) after receiving a First Notice (Friendly) and Second Notice (Certified). Nearly one-hundred (100) Courtesy Notices of Board Intent to Fine were issued in 2024 and not one resulted in a Board deliberation to levy a fine.

Finally, the Board invested a great amount of time and effort keeping members informed of a proposed Affordable Housing Development near our Van Dyke Road entrance. This proposed development appears to be all but a fading memory as the owner of the land, who also developed Van Dyke Farms, is exploring other plans that would be more compatible with our community and greater Odessa area. More to come on that later.

Financially, the Association did very well! We were able to end the year with \$15,691 in surplus recurring funds! The Board is recommending these funds be carried forward and dedicated to the Reserves for Special Projects for long-term improvement and maintenance by the membership at its January 23, 2025 meeting, as we do each year. Additionally, there was a balance of \$64,316 in the Reserves for Special Projects at the end of 2024. This results in a balance of \$130,007 in the Reserves for Special Projects entering 2025 (\$64,316 balance at the end of 2024, \$15,691 in surplus 2024 recurring funds and \$50,000 of budgeted 2025 revenues dedicated to the Reserves for Special Projects). The Association's long-term funding plan is in great shape!

Total revenues in 2024 were \$338,948, 101 percent of the \$334,380 projected. The \$338,948 was comprised of \$316,008 in 2024 assessments (\$750 from 423 owners minus \$1,242 in to be collected assessments), \$18,700 in Tennis Court availability fees and \$4,240 from other areas including delinquent assessment payments, interest, insurance claim and Clubhouse key deposits. Expenses were as follows: Landscape Maintenance (\$76,538); funds set aside for Reserves for Special Projects (\$50,000); Property Management (\$37,496); Landscape Improvements (\$30,510); General Maintenance (\$27,198); Utilities (\$21,047); Insurance (\$19,852); Legal (\$12,214); Lake and Pond Maintenance (\$9,420); Annual Holiday Lighting (\$6,575); Tennis Improvements (\$6,429); Janitorial Services (\$5,151); Irrigation Improvements (\$4,914); Printing and Postage (\$4,717); Pest Control (\$4,518 – includes annual ant treatment); Taxes and License Fees (\$2,078); CPA services (\$1,775); Community Social (\$1,453); Seasonal Decorations (\$593); and, Website Maintenance (\$362).

In terms of Enforcement, 470 violations issued in 2024, which compares to 2023 (473), 2022 (520) and 2021 (505). As of December 31, all but 34 had been remedied and closed. A major focus in 2024 was on Repairing or Replacing Lawns - ninety-six (96) such violations were issued. Of these, 71 have been remedied and closed. Another 16 are being actively managed with significant progress made. There are 9 that show little if any improvement and the Association has given these owners until March 1, 2025, to remedy their lawns or fines and further enforcement action will result. At least 34 of 71 owners have elected to mitigate their Repair or Replace Lawn violation by completely or partially removing the older weed/ insect/mold infested, or otherwise dead or diseased sod in their front vards and replace it with new St. Augustine (e.g., 6903 Agueduct, 6908, 6918 Arabian, 17302 Carriage Way, 17001, 17104, 17105, 17111, 17116, 17120, 17126 and 17130 Downs, 17008, 17108, 17116 and 17209 Equestrian, 6501 and 6519 Grazing, 7604, 7611 and 7613 Lake Cypress, 17122 and 17123 Pasture, 17507, 17518 and 17519 Tally Ho, 6405, 6411, 6523, 6528 and 6624 Thoroughbred, and 17020, 17035 and 17038 Winners). The other 37 were able to remedy their lawns with improved pest and weed control, fertigation and repair of sprinkler systems.


The majority of the remaining 374 violations issued in 2024 were Discolored Driveway/Sidewalk (150) and Trim Palms (75). Of the 423 homes in Van Dyke Farms 160 had no violations issued in 2024 – thank you!

#### 2024 ANNUAL SIDEWALK PRESSURE WASHING


Tampa Power Washing has again been engaged to complete the annual sidewalk and monument pressure washing for an amount not to exceed \$7,398, the same cost as in 2024. The pressure washing is scheduled for early February and will include the common area sidewalks and monuments throughout the community. Additionally, the Playground and Fitness Stations will be cleaned.

#### FLORIDA'S GOLF CART LAW

Florida's golf cart law is now in effect. It increases the legal age to drive a golf cart on public roads. Anyone under the age of 18 is now required to have a driver's permit or license to drive a golf cart on public roads. Under the previous law, you had to be at least 14 years old to drive a golf cart on public roads. As all Van Dyke Farm roads are public please be aware of and ensure the law is followed.

#### PLAN YOUR ACC APPROVAL

As a reminder, major additions, improvements and renovations are required to be approved by the Association's ACC, a five (5) person committee of Association members appointed by, but independent of, the Board. These owners meet monthly (typically the first Monday of the month) to review owner's requests per Article VI of the Association's Master Declaration of Conditions, Covenants and Restrictions (Declaration). Every owner should be familiar with the Declaration and the supporting Guidelines and Standards. These documents clearly define the Association's deed restrictions, what needs to be approved by the ACC, and the process by which to gain approval. These documents can be reviewed by visiting the Governing Document page on http://www.vandykefarms.com or on the Association's G360 web portal in the My Association/Association Documents/Governing Documents folder. IT IS CRITICAL THAT OWNER'S GAIN ACC APPROVAL FOR ADDITIONS, IMPROVEMENTS AND RENOVATIONS PRIOR TO MAKING IMPROVEMENTS. FAILURE TO DO SO MAY RESULT IN THE REMOVAL OF THE ADDITIONS, IMPROVEMENTS AND RENOVATION, AND RESTORATION OF PREVIOUS CONDITIONS. Further, please keep in mind that the Association members who comprise the ACC are your neighbors and are simply trying to ensure the owner's request are compliant with the Association's governing documents. The purpose of the Declaration is to maintain the aesthetics and property values in Van Dyke Farms. Finally, as the ACC meets monthly, PLEASE ENSURE REQUESTS ARE SUBMITTED WELL AHEAD (AT LEAST THREE BUSINESS DAYS) OF MEETINGS TO ENSURE ADEQUATE TIME FOR REVIEW.


#### LET'S KEEP OUR STREETS OPEN

#### February 14th marks the official day of love.

- 141 million Valentine's Day cards are exchanged worldwide.
- 52.1% will buy cards, the most popular Valentine's Day gift.
- More than nine million pet owners are expected to buy gifts for their pets this Valentine's Day; the average person will spend \$5.04 on them.
- People will spend \$1.7 billion on flowers this Valentine's Day, 73% are bought by men, 27% by women

## Way....Please Take Care Of Your Heart.

- How to Survive a Heart Attack If You're Alone!
- Many heart attacks are survivable, especially if you've taken the time to prepare yourself. Anyone who thinks they're at risk for a heart attack should get a complete medical evaluation as soon as possible.
- The information below is far from everything you need to know, but it's enough to point you in the right direction.
- Listen only to advice from medical professionals.
- A widely circulated e-mail recently advocated a procedure called cough CPR as a way to treat a heart attack. The American Heart Association does not recommend that the public use this method in a situation where there is no medical supervision.
- Limit your risk. Listen to your doctor and make changes in your lifestyle to lower your chances of a heart attack. Stop smoking, get regular exercise, improve your diet and reduce stress.
- Buy a device such as the LifeAlert unit (lifealert.net), which automatically links you to rescue or hospital personnel when you press a button.
- Recognize heart attack symptoms. Shortness of breath, pain or pressure in the chest, and pain in the neck or radiating down the arms are all associated with an attack.
- Pull over if you suffer an attack while driving. You may only have seconds before you lose consciousness. Don't try to drive to the hospital no matter how close you are.
- Call 911 and describe what symptoms you're feeling and where you are located.
- Take an aspirin (325 mg) at the first sign of an attack. Aspirin makes blood platelets less likely to stick to each other, assisting blood flow and reducing clots. Chew it up if no drink is readily available—the time and oxygen you waste in waiting to get a sip of something isn't worth it when you're acutely symptomatic.
- Take a beta-blocking drug immediately upon feeling an attack. This is a
  prescription-only drug; if you have a heart condition, you probably
  already have this medication.
- Administer oxygen to yourself. You are likely to have bottled oxygen available only if you have a diagnosed heart condition.
- Thump yourself on the chest as hard as possible. This is very effective when administered by someone else but can be hard to do to yourself.
